#### **Message from the Past President** Jan Cook

I hope you will all find the program for the fall meeting very helpful in understanding the machinations taking place in Columbus. You have all heard and worked with TAG's. You may even be aware of placement issues that will soon affect your institutions. I wanted to provide a view of the whole picture --- how these projects are related and how they will affect you.

I have had the privilege of working with Ed Laughbaum on an OBR committee dealing with High School to College Articulation. The committee has identified assessment and placement as keys in the smooth transition from high school to college. Ed, then, is ideally placed to assist in the placement piece of this endeavor. The EMPT is in place and provides the information that has been identified as necessary. He will relate what other instruments the committee is considering and the directions it may take.

Some of the work on the placement part of the OBR committee has included case studies of placement programs at two and four year institutions. The participants of these case studies included the mathematics (and English) programs at The Ohio State University. Dr. Dan Shapiro coordinated the case study in mathematics and will summarize the process and results. Since OBR is being asked to consider standardizing a placement process, we all need to be aware of the procedures currently being looked at.

Our final presentation is from Patrick Bibby, from Miami Dade County, who will update us on the Mathematics Across the Community College Curriculum Program (MAC<sup>3</sup>). He will give us ideas to take back to our campuses for implementing the concept locally. Can we make it unusual for people to freely admit they "don't get math?" It's a goal!

Plan to join us on Friday, October 5, 2007 at Columbus Community College. Update your understanding of topical subjects and share your experiences with colleagues. This is always a good time.

### Special Recognition

Barbara Carruth of Sinclair Community College was recognized as Professor Emeritus at the 2007 commencement exercises. With only two such honorees each year, this is an exceptional honor for Barb who retired from fulltime teaching in 2005. Starting part-time in 1978 and later becoming a full-time tenure-track member in 1985, Barb was very involved

professionally in mathematics organizations and in presenting at conferences. She did pioneering work at Sinclair in incorporating graphing calculator technology in the classroom and was extensively involved in the teaching of statistics as a lab-based course. She was one of a team of four who earned the college's prestigious Innovator of the Year Award in 2002 for her teaching approaches in mathematics. She was also Sinclair's nominee for the 2005 OATYC Faculty Member of the Year Award. Barb has continued to teach part-time at Sinclair since her retirement.

# Metacognition

## Helping Students Think About Their Thinking

In my Elementary Statistics classes (Web, Hybrid, and Traditional), I present a "Motivator of the Week". This quarter one in particular seemed to make an impression on a many of my students.

The students were provided a brief summary of the dynamics of metacognition, including why thinking about thinking results in more efficient and effective encoding of information. To practice cognitive processes, students were encouraged to ask themselves what?, when?, and how? while taking notes and working through homework.

To help them with this process they were provided an "If/ then" table, leaving the "then" side blank for students to complete. I listed about 20 "if" statements and left space for more to be added as the quarter continued. For example, if:

P(A, given B)

P(A or B)

Uniform distribution and asked to calculate a probability Provided n and p, and asked to find expected value

Many students commented on how much this helped them prepare for the test, and that they were adding to it for the next test. One such response made my quarter:

"At the beginning of the quarter, I would never have thought that at some point I might anticipate getting an "A" on any math test (ever) - certainly not in statistics and certainly not on the final. However, your motivational activities (especially the table) have done wonders for my ability to get this information straight. I shake my head in amazement as I type this, but I fully intend to get an "A" on this final, and more importantly than that, I will actually retain it." (Hybrid student)

Question: Why is 6 afraid of 7?
Answer: Because 7 8 9!

# **Driving Directions:**

**From the East**: Take I-70 West to I-71 North, to the Broad Street exit. Go left on Broad Street to the first street on the right (Jefferson Avenue.) Turn right onto Jefferson Avenue, follow Jefferson Ave. across Long and Spring Streets and into campus.

**From the North**: Take I-71 South to the Spring Street exit, which exits on the left side of the highway. Go right on Spring Street. Make an immediate right on Jefferson Avenue into campus.

**From the South**: Take I-71 North, to the Broad Street exit. Go left on Broad Street to the first street on the right (Jefferson Avenue.) Turn right onto Jefferson Avenue, follow Jefferson Ave. across Long and Spring Streets and into campus.

From the West: Take I-70 East to I-71 North, to the Broad Street exit. Go left on Broad Street to the first street on the right (Jefferson Avenue.) Turn right onto Jefferson Avenue, follow Jefferson Ave. across Long and Spring Streets and into campus. Once on campus, follow around until you see a walking ramp on your left. Parking will be on your right, Delaware Hall Athletic Center is on your left.

**From Port Columbus International Airport**: Exit Airport at Stelzer Road to I-670 West. From I-670 West, exit at I-71 South, then take the first exit at Leonard Avenue/Cleveland Avenue. Go left on Leonard Avenue, Then left again on Cleveland Avenue. Columbus State will be on the left.

**PARKING:** Attendees can park in any student lot (passes will be provided). Visitor spots are metered, so do not park in visitor lots.
